- Communication to check the awareness of guardians interaction with teachers.
- Competency to check the awareness of the capability of guardians to provide online education.
- Well-being to check the awareness of guardians for the well-being of children.
- Deportment to check the awareness of guardians behavior towards children & online education.

All questions are in an online questionnaire based on the above dimensions.

The questionnaire is provided only to guardians of different categories in urban and rural areas. Questionnaires were divided into different dimensions and all guardians completed questionnaires in online mode within the provided time period. The researcher gives one mark for yes and zero marks for no answer.

Statistical Technique to be Used

A survey was undertaken to collect quantitative data to be analyzed statistically and make assertions about it.

Analysis & Interpretation of data

The guardians gave their opinion on the statement in the form of yes or no. All respondents give answers in yes or no. respondent data was collected with the researcher's help by giving her complete information about the questionnaire. All respondents give their opinions.

Data is collected with the help of the above-mentioned tools are scored and tabulated and analyzed in terms of mean, standard deviation then T-test is used to find out the significant difference.

Hypothesis No - 1 States that

• Guardians of the urban & rural areas have equal awareness towards online education in the Covid-19 pandemic.
